

# Crypto FAQs

### **Does the IRS Recognize Crypto Donations?**

The IRS classifies cryptocurrencies as property, so crypto donations to 501c3 charities receive the same tax treatment as stocks. <u>Learn more here.</u> When donating crypto, you receive a tax deduction for the fair market value of the crypto, and you avoid the capital gains tax you would have incurred if you had sold the crypto and then made a donation. That means you're able to donate more, as well as deduct more on your tax return. The difference? Sometimes more than 30%.

#### Why should I donate Crypto?

Donating crypto is potentially a non-taxable event, meaning you may not owe capital gains tax on the appreciated amount and can therefore likely deduct it on your taxes. Donors may wish to consult their tax advisor about the tax consequences of making a cryptocurrency gift, as well as the documentation required in order to claim a deduction. #### Will I get a receipt with my donation?

In order to receive an e-receipt with your donation, you must enter your email when prompted to in our widget. You will also receive a gift acknowledgement letter from WRA in the mail following your gift.
